#### **CORRESPONDENCE:**

 Notice from the Village of DeRuyter dated July 30, 2008 that a decision was made by that board on March 17, 2008 to increase the fire department budget to \$110,000 and to notify the Town that next year's fire protection amount will be \$88,000.

### **UNFINISHED BUSINESS:**

**#57 RESOLVED**: That this Town Board does hereby authorize the increase of Revenue line DB3501 (State Aid for CHIPS) by \$13,000 and increase Estimated Expenditure line DB51112.2 (CHIPS Expenditure) by \$13,000; increase revenue A3040 (State Aid for Assessment) by \$2,900 and to increase estimated expenditure A1355.2 (Assessor's Equipment) by \$2,900 to pay for computer equipment and transfer \$400 from A1990.4 (contingent) to A1220.4 (contractual) to pay for Supervisor Training expenses.
