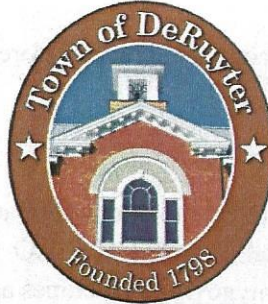

TOWN OF DERUYTER BID #12-2018

I. PURPOSE

The Town of DeRuyter is requesting bids for the purchase of a Used 2016 (or newer) Ford F-550 4x4, or equivalent, with a dump body and a Western, Fisher, or Boss 9'6" Stainless V-plow

II. OBJECTIVE

The objective of this Request for Bids is for the Town of DeRuyter to select a respondent to furnish the Town with:

1. Used 2016 (or newer) Ford F-550 4x4, or equivalent, with dump body.
2. 9'6" Stainless Steel V-plow manufactured by Western, Fisher, or Boss to be installed on said truck.

III. GENERAL SPECIFICATIONS - TRUCK

1. Ford F-550, or equivalent, standard cab
2. 4x4, dually
3. Diesel
4. Automatic Transmission
5. 9' Dump Body
6. Mileage less than 10,000

IV. GENERAL SPECIFICATIONS - PLOW

1. 9'6" Stainless Steel V-Plow
2. Acceptable Manufacturers: Western, Fisher, Boss
3. Installation on truck to be included

1. Bids will be accepted on dealer's letterhead in any format.

3. Bids will be opened and read aloud at 1:00 pm on January 7, 2019 in the 1st Floor Conference Room of the Genevieve D. Staley Civic Center, 735 Utica Street, DeRuyter, NY 13052. Any bid received after this time will not be considered.
4. The Bid Award is anticipated to occur at the DeRuyter Town Board Meeting on January 10, 2019 at 7:30 pm at the 1st Floor Conference Room of the Genevieve D. Staley Civic Center, 735 Utica Street, DeRuyter, NY 13052.

VIII. PRE-AWARD INSPECTION:

The Town of DeRuyter reserves the right to inspect the Truck and/or plow equipment prior to awarding the bid.

IX. PAYMENT TERMS:

Full payment to be made upon delivery.

X. DISPUTES, APPLICABLE LAW, ATTORNEY FEES:

The Contract shall be governed by and construed in accordance with the laws of the State of New York. In the event of a dispute, the parties herein agree to the jurisdiction of the Courts of Madison County, State of New York and waive any objection thereto.

If any party shall breach this contract, the non-breaching party shall be entitled to attorney's fees in addition to any other damages, whether or not the matter goes to trial.

XI. DISCLOSURE:

The Town of DeRuyter reserves the right to reject any or all bids. Additionally, the DeRuyter Town Board reserves the right to award based upon "Best Value" at the board's discretion.
