Staley Civic Center, 735 Utica Street, DeRuyter, NY.

- Insurance Discussion an approximate increase of \$200 will raise the coverage on the "old" garage to \$40,000.

We will need to find out what types of materials are involved. Motion by Councilmen Coon and Barnes to have necessary testing completed. All in favor and carried.
- Equipment replacement current assets, their year purchased, projected replacement year and projected replacement cost were reviewed.
- Plowing needs were discussed. John Farewell will not be plowing Camp Crone Road for us this year so, an alternate solution will have to be found.
- Bridges and culverts in the Town were discussed.
- A Town Road inventory was discussed.
- Other highway related concerns Councilman Coon suggested that extra signage and possibly speed limits should be in place on Dugway Road. Motion by Councilmen Coon and Jones to adopt:

#48 RESOLVED: Whereas, On August 3, 2012 a fatal vehicle/pedestrian accident at 2575 Dugway Road in the Town of DeRuyter involving a four year-old child occurred; and

Whereas, Dugway Road is a roadway owned and maintained by the County of Madison as County Route #60; and

Whereas, the continued safety within this particular area of Dugway Road is of concern to the DeRuyter Town Board; and

Whereas, the DeRuyter Town Board, along with the residents residing in this particular area, believe pedestrian signage and a reduced speed zone would be beneficial to ensure public safety along this particular area of Dugway Road.

Now Therefore Be It Resolved, that the DeRuyter Town Board respectfully request the Madison County Superintendent of Highways install pedestrian signage in the area of 2575 Dugway Road within the Town of DeRuyter, and

Be It Further Resolved, that the DeRuyter Town Board request a speed study to be conducted in the area of 2575 Dugway Road within the Town of DeRuyter resulting in a reduced speed zone extending from the Dugway Road intersection with State Routes 13 and 80 easterly through the area of 2575 Dugway Road and ending east of the Dugway Road/Barrett Road intersection.
